Sub: Election of the Delegates – 2018-2021

1.00 The undersigned has been directed by the BOARD OF DIRECTORS of the Society to bring to the notice of all concerned that as per Rule 13 (2) of the Multi State Cooperative Societies Rules, 2002 and Byelaw No.29 of the Society the Annual General Meeting of this Society shall be held by convoking representatives (hereinafter referred to as 'Delegates') of Constituencies, instead of summoning all the Members in person, on the basis of slabs of the representation at the ratio of one Delegate for every 40 (Forty) Members or major fraction thereof.

1.00 Under Rule 13(2) of the Multi-State Cooperative Societies Rules, 2002 and Byelaw No.46 (1) of the Society the BOARD OF DIRECTORS have resolved in its meeting dated **27 04 2018** to divide the area of membership of the Society into convenient **29 (Twenty Nine)** Constituencies for the purpose of the **Election of Delegates - 2018**.

1.01 As required under Byelaw No.29 (6), the division of the area into Constituencies together with number of Members registered at each area of the Constituency and number of Delegate(s) to be elected from each Constituency as indicated in Annexure – 'A' to this Notice, is hereby notified to all the Members.

1.02 The Draft list of the Members (hereinafter referred to as Voters' List) of the Steel Authority of India Employees' Cooperative Credit Society Limited showing Serial Numbers, Membership Numbers, Personal Numbers and Names of the Members according to Constituency to which the Members belong, shall be published by the Society on **01st June 2018 (Friday)**.

The final list of the Members (Voters' List) shall be published on **08th June 2018 (Friday)**.

2.01 Submission of Nomination Paper

Nomination Paper(s) will be available from the Returning Officer/Election Officers/Polling Officers on and from **12th June 2018 (Tuesday)** from **12:00 PM to 05:00 PM** on an application. The last date of submission of Nomination Paper (s) with the Returning Officer/Election Officers/Polling Officers is **18th June 2018 (Monday)** upto **05:00 PM**.

A Nomination Paper shall be signed by two voters, one of whom shall sign as Proposer and the other as the Secodar. The Nomination Paper shall also contain a declaration signed by the candidate to that effect that he/she is willing to contest at the Election of Delegates. The candidate, the Proposer and the Secodar must belong to the same Constituency from which the candidate seeks Election.

Scrutiny of Nomination Paper

The scrutiny of Nomination Paper(s) will be done on **19th June 2018 (Tuesday)** between **12:00 PM and 04:00 PM** at the Office of the Society (in respect of Kolkata based Constituencies) and in the Offices of the respective Election Officers (in respect of Branch-based Constituencies).

The Proposer, the Secodar, the candidate or his/her agent may be present at the time of scrutiny of Nomination Paper(s).

Withdrawal of Nomination Paper

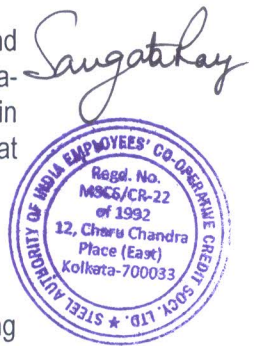

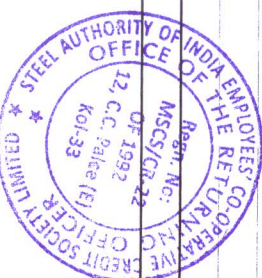

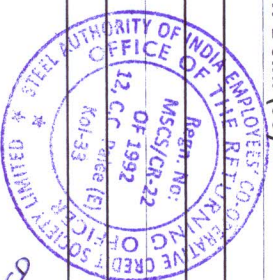
